### **Key Issues Discussed were:**

- 1. The status of the recruitment to fill the vacancies in the Domestic Violence Unit;
- 2. The current number, adequacy and opening hours of safe houses in Trinidad and Tobago;
- **3.** The status of the four shelters under construction/refurbishment by the Ministry of Works and Transport;
- **4.** The response time of the TTPS after receiving a report of domestic violence;
- 5. The procedure by the VWSU after receiving a report of an incident of domestic violence;
- **6.** The counselling services available at the NFSD and the VWSU for the perpetrators of domestic violence:
- 7. The need for strengthened coordination amongst the various stakeholders of domestic violence inclusive of the MSDFS, VWSU and OPM;
- **8.** The factors that determine the choice of radio station and time slot for the 'Let's Talk' Radio Programme;
- **9.** The various outreach initiatives done by the TTPS, MSDPF and OPM to sensitize the citizenry on domestic violence;
- **10.** The current status of the Central Registry on Domestic Violence and the need for information sharing of the data collected by the Central Registry on Domestic Violence to other stakeholders of domestic violence;
- 11. The 24/7 availability of the VWSU personnel and shelters to victims of domestic violence;
- **12.** The process used to track the enforcements of protection orders and response time of the TTPS to reported breeches to protection orders of perpetrators of domestic violence;
- 13. The current VWSU staffing and infrastructure at police stations; and

**14.** The placement of domestic violence victims into a shelter via a referral process through domestic violence hotline 800-SAVE.
