KEY ISSUES DISCUSSED

(i) The issue that triggered the inquiry i.e. the failure of an assigned State Attorney to appear at a preliminary inquiry in relation to a murder charge fixed to begin on Friday January 20, 2017, and the dismissal of the matter as a result

- (ii) The limited physical and human resources at the Service Commissions Department which limits its ability to perform regular functions
- (iii) The need to prioritise the needs of the Office of the DPP, in light of the implementation of the Criminal Procedure Rules, 2016, the worsening state of crime and the potential passage of legislation dealing with the abolition of preliminary inquiries¹
- (iv) The progress made towards filling vacancies at the Office of the DPP
- (v) The development and implementation of an electronic Case Management System at the Office of the DPP
 - a) The reasons for the failure to implement the electronic Case Management System
 - b) The manual system utilised in the absence of an electronic Case Management System
 - c) The proposed timeline for the implementation of the electronic Case Management System
- (vi) The lines of communication between the DPP and the DPA
- (vii) The process followed by the Judicial and Legal Service Commission to recruit legal staff at the office of the DPP
- (viii) The proposed timelines for resolving the issues being faced at the Office of the DPP
- (ix) The negative impact of the staffing deficiencies on the operations of the Office of the DPP
- (x) The issue of remuneration packages at the Office of the DPP

- (xi) The feasibility of establishing a Financial Crimes Unit at the Office of the DPP
- (xii) The negative impact of administrative staff shortages at the DPP's Office and the preference of obtaining specialist staff given the organisation's mandate
- (xiii) Progress made towards acquiring adequate accommodation for the DPP's offices in Port of Spain, San Fernando and Tobago and the negative effects of inadequate accommodation on staffing
- (xiv) The issue of the DPP's office being allocated its own budget.

Note: A follow-up hearing regarding this inquiry topic will be held with officials on Friday April 07, 2017.
