- The status of the Integrated Financial Management Information System (IFMIS);
- The Status of the overdraft on the Exchequer Account;
- The explanation of the term "incorrect classification of expenditure";
- The non-adherence to management letters sent by the AGD;
- The recommendations for the non-submission of lease agreements;
- The status of the arrears for taxes on income and profit;
- The status of overpayments at Ministries and Departments and the mechanisms in place for the recovery of overpayments;
- The recommendations for the submission of pension and leave records for auditing in a timely manner;
- The process for the auditing of Overseas Missions;
