# The Motor Vehicles Insurance (Third-Party Risks) (Amendment) Bill, 2013

#### Background

The Motor Vehicle Insurance (Third-Party Risks) Act<sup>1</sup> was first passed in 1933. Since then it has been amended on sixteen (16) occasions.

## What is the purpose of the Bill?

The Bill seeks to amend section 4 of the Motor Vehicles Insurance (Third-Party Risks) Act.

## What are the key features of this proposed legislation?

- ✓ The Bill repeals and replaces section 4(7) of the Motor Vehicles Insurance (Third-Party Risks) Act.
- ✓ The Bill proposes that, notwithstanding any other law, a person issuing a policy of insurance (an "insurer" as defined in the parent Act Chap 48:51) shall indemnify the person insured, any person specified in the policy or any person driving or using the vehicle or licensed trailer with the consent of a person specified in the policy in respect of any liability which the policy covers.

### Points to note

✓ The amendment proposed by this Bill only varies from the existing subsection of the Act as per subparagraphs (c) and (d).

### Considerations

- ✓ Implications for insurers if insured persons refuse to specify persons in insurance policies because said persons now have the power to give consent for the use of a motor vehicle without reference to the person insured.
- $\checkmark\,$  Issue of proof that the insured person has given consent to another to use a motor vehicle.
- ✓ Implications for persons using a vehicle in the course of their employment.
